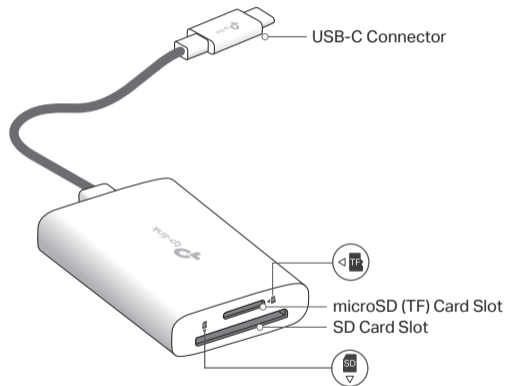

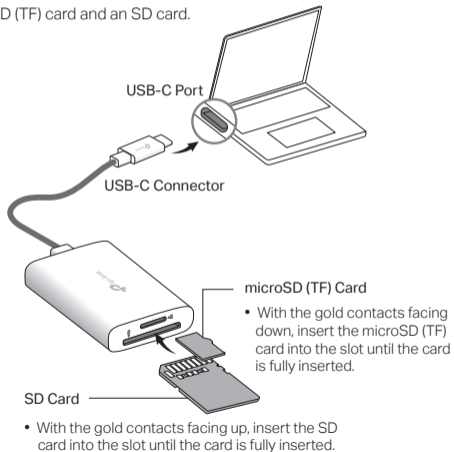

2 Using the Adapter

This adapter supports the Plug and Play feature. Plug the USB-C connector into your host device, then plug in your microSD (TF) card and SD card onto the corresponding slot.

Note: This device supports simultaneously reading and writing a microSD (TF) card and an SD card.

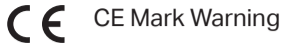
